

Terms and Conditions

WIZETRADE/STOCK HIDEOUT PAPER TRADE CONTEST DESCRIPTION: The Wizetrade/Stock Hideout Paper Trade Contest (“Contest”) begins at 9:30 a.m. EDT on June 1, 2009 and ends at 4 p.m. EDT on Aug. 31, 2009 (“Contest Period”). Entrants must use the Wizetrade Stocks Trade Manager to participate in the Contest. The Contest is for Paper Trades only; trades made outside the contest dates will not be considered as part of the contest. The top three accounts that have the highest percentage gain will be selected as the first-, second-, and third-place winners.

THE PRIZES: Wizetrade will sponsor the following prizes for the top three winners:

Stock Hideout Members can enter the contest on the Stock Hideout Website. Each Contest participant will have to have his/her paper trade account reset to \$50000.00 on the day prior to start date of contest. Members must use the Wizetrade Stocks Trade Manager to participate in this Contest. Employees of Wizetrade are not eligible. Contest is void where prohibited.

2. Click on the Support tab
3. At the bottom right, fill out the section Report an Issue.
4. In the Brief Description box type in "Stock Hideout Traders Challenge"

The request will be sent to Wizetrade Service and Support team to reset your paper trade account balance to \$50000.00.

Be advised: this will clear out your paper trade Trade Manager.

If your balance is not reset by the morning start date of the contest, please call 800.304.8881, option 3 for Wizetrade Service and Support. Be sure to identify yourself as a Stock Trader member who needs your account to be reset for the paper trade contest. Doing so will help us prioritize your request, otherwise, your account might not be reset until the end of the day.. Remember: Resetting the paper trade account balance in the Trade Manager will erase any and all details within the Trade Manager, including any trade history.

WINNER SELECTION AND VERIFICATION: The top three accounts that have the highest percentage gain as of the close of market at 4 p.m. EDT on Aug. 31, 2009 will be selected as the first-, second-, and third-place winners. Winners will be notified by phone or email.
